1. The candidates must possess the required qualifications at the time of last date fixed for receipt of online applications in the Advertisement that is 25/04/2023. No updating of qualifications and experience will be entertained after the last date of the submission of online application.
2. The Last Date for receipt of Online Applications is fixed as 25/04/2023.
3. Applicants must send/submit One hardcopy of the application (Without Spiral Binding) in the envelope super scribe with "Post Applied for and the name of Department" to the office of Registrar on or before 28/04/2023 along with all Self-Attested Mark sheets, Degree/Masters/Ph.D. Certificates, Experience Certificate, Research Papers, Testimonials etc. along with supporting documents relating to his or her Academic/Research Score to substantiate his or her candidature or else the application will not be considered.
4. The Prescribed application fees is Rs. 1500/- (One Thousand Five Hundred only) for Unreserved Category and 750/- (Seven Hundred Fifty only) for Scheduled Caste(SC)/ Scheduled Tribe(ST)/ Socially and Economically Backward Class(SEBC)/ Economically Weaker Section(EWS) payable online and Transaction ID should be attached with the hard copy of his or her application without fail.
5. Persons with Benchmark Disability (PwBD) are fully exempted from payment of the prescribed fees upon submission of relevant Disability Certificate issued by the competent authority as per the policy of Government of Gujarat. The eligible PWD candidates shall only apply to the concern Advertisement.
6. A recent scanned passport sized colour photograph of candidate in JPG,JPEG& PNG format only (the digital size of the file must be up to 50 KB and resolution 200 pixels X 230 pixels is preferred).
7. Scanned signature of Candidate using Blue/Black pen on white sheet in JPG,JPEG& PNG format only (the digital size of the file must be up to 50 KB and resolution 140 pixels X 60 pixels is preferred).
8. Bank charges towards the online payment service as applicable will be additionally payable by the candidates.
9. Candidate has to first register themselves on [www.sgggu.ac.in/recruitment](http://www.sgggu.ac.in/recruitment) for submitting his or her online application for the teaching post.
10. Once candidate has applied and confirmed his/her application online, the candidates will not be permitted to edit anything in the application form. If the candidate have submitted more than one application, the last application will be considered, subject to the fee paid with this application.
11. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid any kind of delays due to the unforeseen events or circumstances. The University shall not be responsible for any delay at anystage.



12. Experience shall be considered after obtaining the requisite educational qualification.
13. The applicant must ensure that he/she fulfils the eligibility conditions for the Post.
14. Grade point which is on a scale of seven, following mechanism shall be referred to ascertain equivalent marks in percentage.

15. The time taken by the candidates to acquire M.Phil. and or Ph.D. Degree shall not be considered as Teaching/Research Experience to stake claim for appointment to the Teaching Positions.  
However “the period of active service spent on pursuing Research Degree i.e. for acquiring Ph.D. degree simultaneously without taking any kind of leave may be counted as teaching experience for the purpose of direct recruitment to the post of Associate Professor and above.” The experience gained as honorary/Part-Time/Visiting/Trainee/Adjunct faculties will not be considered as experience.
16. The candidates applying for the Posts of Associate Professor must enter the relevant Research/Academic Score (A/R Score) in the space provided against the given categories in each of the Column and it must be supported by documentary evidence, without which no claim on account of Research/Academic Score would be entertained.
17. The candidates applying for the Posts of Professor/Associate Professor shall necessarily submit Self-Attested One Copy of Top Ten Research Papers [For the Post of Professor]/ Top Seven Research Papers [For the Post of Associate Professor] / Top Five Research Papers [For the Post of Assistant Professor] respectively, along with his or her applications.
18. The candidate shall enclose Self-Attested Copies of Certificates towards the evidence of Educational Qualifications, Caste, Physical Disability, Experience, etc. with his or her applications without fail.

21. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Socially and Economically Backward class (SEBC)(Non-Creamy Layer)/Differently-abled ((a)Blindness and Low Vision; (b) Deaf and Hard of Hearing;(c) Locomotors Disability including Cerebral Palsy, Leprosy Cured, Dwarfism, Acid-Attack Victims and Muscular Dystrophy; (d) Autism, Intellectual Disability, Specific Learning Disability and Mental Illness;(e) Multiple Disabilities from amongst persons under (a)to(d) including Deaf-Blindness)for the purpose of Eligibility and assessing Good Academic Record for Direct Recruitment. The eligibility marks of 55% marks (or an Equivalent Grade in a Point Scale wherever the Grading System is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
22. Applicants awarded degrees by Foreign Universities shall be required to submit Equivalence Certificate issued by Association of Indian Universities, New Delhi. The University reserves the right to require Equivalence Certificate for various degrees from any of the applicant.
23. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree Prior to 19 September, 1991.
24. Reservation for SC/ST/SEBC/EWS and Persons with Benchmark Disabilities will be as per existing policy of Government of Gujarat and Reservation for SC/ST/SEBC and EWS should be applicable to Gujarat domicile candidates only.
25. Candidates seeking reservation under Scheduled Caste (SC)/ Scheduled Tribe (ST) Category are required to submit Certificate on the format prescribed by the Government of Gujarat.
26. Candidates seeking reservation under Socially and Economically Backward Class Category are required to submit Non-Creamy layer Certificate on the format prescribed by the Government of Gujarat. The certificate issued in Gujarati (परिशिष्ट-५) only accepted, whereas the certificate issued in the English (Annexure- A) shall not be accepted, as this certificate is meant for Government of India. The Non-Creamy layer certificate shall be issued after 01-04-2022 to the last date of online application i.e. 25/04/2023 shall be considered as valid certificate. The married women candidate should submit Non-Creamy layer certificate obtained on the basis of the income her parents. If such certificate obtained on the basis of the income of her husband shall not be considered and application liable to be rejected.
27. Candidates applying for the Post (s) reserved for socially and Economically Backward Class (SEBC) should submit a Self-Attested Copy of Valid Caste Certificate specifically mentioning Creamy Layer-Exclusion in the format prescribed by Government of Gujarat.
28. Economically Weaker Sections (EWS) vacancies are tentative and subject to further directives of Government of Gujarat and outcome of any litigation. 29. The qualifications regulations/norms stipulated and other service conditions prescribed in the present advertisement are as per the Gazette Notification of UGC Regulations,2018 (Minimum Qualifications for Appointment of Teachers and Other Academic Staff in University) and subsequent amendments, if any shall be applicable as amended from time to time.
30. The minimum requirement of a consistently 'Good Academic Record' shall be 55% marks (or an Equivalent Grade in a Point Scale wherever Grading System is followed) at Master's level, and at least 50% marks (or an Equivalent Grade in a point scale wherever Grading System is followed)at Bachelor's Examinations or an Equivalent Degree from an Indian/Foreign University, and Qualifying in the National Eligibility Test (NET) conducted by the UGC, CSIR, or similar test accredited by the UGC like SLET/SET shall remain in force for the Direct Recruitment for the Post of Assistant Professor in the university (OR) consistently Good Academic Record shall be an average record of 3rd year (Final Year) Degree & Master Degree Level assessment which would at least be 52.5% or M.Phil. or Ph.D. as applicable in case of UGC Regulations.
31. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not be entitling him/her for being called for personal interview.
32. No TA/DA shall be paid to candidates for attending Screening Test/Personal Interview.
33. Screening of applications shall be decided by Shri Govind Guru University, Godhra.
34. Appointed teachers may be assigned other academic or administrative responsibilities in addition to their regular teaching and research.
35. Candidate selected and appointed as Assistant Professor shall have to undergo and successfully complete In-service Teachers' Training Programme during their probationary period of two years which shall be an essential condition for the confirmation in service in the university.
36. The language of administration in the University is Gujarati. However, knowledge of English language is highly desirable.
